### **Boone Dam Repair Project Community Meeting Draws More Than 300 Attendees**

TVA held a community meeting to provide details on the repair plan for the Boone Dam earthen embankment on July 30, 2015 in Johnson City. More than 300 area residents and business owners attended the public meeting. Following a presentation by TVA Vice President John McCormick, the public was invited to ask questions of McCormick along with two other TVA vice presidents, John Kammeyer and Rebecca Tolene.

### **Test Grouting Program Underway**

Work began this week on the Test Grouting Program for the earthen embankment. The testing will provide valuable information on the most effective type of grouting method for the final solution as well as a better understanding of geological conditions near the earthen embankment.

***NOTE: Due to the angle of the photo, the power lines appear within close proximity of the drill rig. The power lines are actually 48 feet from the drill mast.***
