# TVA to Offer Volunteer Archaeological Site Stewardship Training

TVA is looking for volunteers with a sincere interest in the protection and preservation of archaeological sites in the Tennessee Valley for TVA's Thousand Eyes Archaeological Site Stewardship Program. The volunteers will work with TVA archaeologists to monitor archaeological sites for vandalism and environmental damage. The upcoming training workshop will focus on archaeological sites located on Boone Reservoir. # Reminder: Environmental Review Input Needed by September 8

The Boone Dam Repair environmental review process has begun, and this is a reminder that TVA is inviting the public to provide input on the scope of the review and environmental issues that should be addressed during the review. The public may also submit relevant information for consideration in the environmental assessment.

This review will analyze the environmental impacts of the construction activities at the dam as well as the associated drawdown of the reservoir. TVA requests that input be provided by **September 8—one week from today**. Input on relevant environmental issues may by submitted electronically in one of several ways:

Please note, this public comment period is limited only to environmental issues and concerns associated with the proposed repair project. Since our July 30 community meeting, TVA has received a number of comments from the public and stakeholders about the repair project. These comments will also be considered as part of the environmental review scoping process. If you have provided comments to TVA, you do not need to resubmit these comments via the online form.

TVA will complete the draft environmental assessment this fall and will make it available to the public for review and comment.

### Will there be local jobs available?

Once the primary contractor is in place, we anticipate some local sub-contractors and suppliers will be used. TVA will follow the project maintenance and modification agreement that is in place between TVA and the unions comprising the Tennessee Valley Trades and Labor Council.
