Description of Proposed Action Continued from Page 1

TVA's proposed action is to refurbish and reopen access to the boat ramp at the John Sevier Gas Plant at 611 OLD HWY 70 S, Rogersville, TN 37857-5401. Access was closed to the boat ramp in 2015 when the coal plant ceased operations and the site was undergoing closure and decommissioning. TVA would replace and repair parking areas as needed. A kiosk would be reinstalled on a new concrete pad. The project area would be graded as necessary for proper drainage, and some graveled areas would be replaced with topsoil and grass. To enhance the use of the area for the public, TVA plans to maintain six picnic tables and four trash cans. New fences with gates will be installed where necessary for public safety and protection of TVA's facilities at John Sevier. TVA held a 30-day comment period to solicit public input on the proposed action to reopen the boat ramp. Appendix A provides details about the comments that were received as well as TVA's response to those comments.

8. Temporary closure of this recreation facility suspended recreational boating access to the section of Cherokee Reservoir located between a shoals that spans the Holston River at mile 104.8 and John Sevier Detention Dam. In the past this facility has been used to gain boat access to these waters, primarily to engage in boat fishing. Re opening will restore the substantial public recreation opportunities and associated benefits this facility has provided in the past.

Closure of the bank fishing walkway along the old fossil plant discharge channel will reduce bank fishing access to the waters immediately below the detention dam. However, some informal bank fishing opportunities will continue to be available in the general vicinity including a walk-in area located on the north bank just above the shoals and at an informal bank fishing area with parking accommodations at the US Highway 70 bridge crossing near river mile 103.

## Appendix A – Public Comments Received for the TVA John Sevier Boat Ramp

TVA is considering refurbishing and reopening access to the boat ramp at the John Sevier Gas Plant at 611 OLD HWY 70 S, Rogersville, TN 37857-5401. Access was closed to the boat ramp in 2015 when the coal plant ceased operations and the site was undergoing closure and decommissioning. A popular fishing site, TVA has received numerous requests to reopen the area.

TVA held a 30-day comment period to solicit public input on the proposed action to reopen the boat ramp. The notice for public comment was posted on TVA's website and TVA reached out to members of the public who had shown previous interest in the project. Notices were sent to several media outlets including *the Rogersville Review*, *Kingsport Times*, *Johnson City Press*, *Johnson City News & Neighbor*, *Herald and Tribune*, *Greeneville Sun*, *Good Day Tri Cities*, *Elizabethton Star*, *Citizen Tribune*, *Bristol Herald Courier*, WJHL-TV, WCYB-TV, and WBEJ-AM.

The comment period opened on April 10, 2017, and closed on May 9, 2017. The public was asked to submit comments by email or mail. TVA received 34 responses which included a total of 116 signatures.

Comments were grouped into three common categories:

1. Please reopen the boat ramp at John Sevier.
2. Please reopen the boat ramp, pedestrian fishing access, and walking facilities at John Sevier.
3. Do not reopen the boat ramp at John Sevier.

TVA's responses to these comments are provided below. Copies of all the comments that were submitted are also provided.

---

**Comment #1:** Please reopen the boat ramp at John Sevier.

**Response:**

TVA's proposed action is to reopen the boat ramp facility at John Sevier. Thank you for your comment.

**Comment #2:** Please reopen the boat ramp, pedestrian fishing access, and walking facilities at John Sevier.

**Response:**

TVA's operating permit and safety and security concerns at the site require us to limit access to the coal ash storage areas. They are fenced but it reduces the space and activities allowed in this area. Only boat access will be allowed at the ramp and the campground will remain closed. Due to the discharge channel not having flowing water and permit requirements to limit access, the fishermen's walkway will not be reopened.

**Comment #3:** Please do not reopen the boat ramp at John Sevier. It could benefit the fishery as a whole for the fish to have the opportunity to spawn in the river without much disturbance from fisherman.

**Response:**

Following closure of the boat ramp in 2015, TVA made a commitment to consider reopening access to the fishing area following completion of construction activities at the fossil plant site. The Cherokee Reservoir Fishery has been studied since the 1970s. The most recent monitoring revealed a healthy, numerous collection of fish. This area has received an overall “good” reservoir fish assemblage rating for years with and without the boat ramp access. After careful consideration, TVA proposes to reopen access to the boat ramp and does not feel that this action will have a negative impact to fish in the area.

Dear Ashley,

My name is Paul Allison, thanks for the email regarding the reopening of the boat ramp at John Sevier. This is an important step to restore public access to fish waters enjoyed by the public for many years. However, I hope that TVA is still working toward reopening public access to the bank fishing up around the dam also. When this area closed in the summer of 2013, I collected over 3000 signatures on a petition to show the public's strong desire for this area to reopen as soon as it can once the demolition on the old plant site is done. I sent copies of the petition to TVA, as well as our local, state and federal politicians. Later that summer TVA met with us at the John Sevier site. I was there with other local parties and Bill Snodgrass from congressman Phil Roe's office. The meeting went well, and TVA told us that this closure should not be permanent. Not long after that TVA put me in touch with Jerry Fouse. That next spring I met with him and another man and we spent 2 or 3 hours driving and walking around the old plant site and fishing area around the dam, so they could see what options we might have to reopen this area to those of us that don't have boats and can only fish from the shore. I have stayed in touch with Jerry over the past 3 years and I know that they have submitted a proposal that would allow the public access to this area once again, (after the demolition work is done on the old plant site), and that also takes into account all the safety concerns of TVA. If you would be so kind, could you get back to me with an update on this issue, because people are still asking me about this all the time. Thanks and God Bless.

Someone is going to get hurt and this doesn't have to happen and what happened today would never have happened if the boat ramp had been open. I hope everyone understands all the problems the ramp being closed has caused and I hope you reopen it before someone gets hurt.





Both my children (ages 6 & 8) have since earned state records in running and it's because of us taking them to the track so much. My daughter actually cried when the track was closed, she was four years old at the time. She has earned four state records for various races since she was four. There is no other place like it! We loved the length of track and the view of the river while we ran. I really liked the gravel on the track because it was so easy on our joints. We have searched for alternative tracks and there is nothing comparable or close by for the people in the local community. My father-in-law continues running in the area on the main road (Old Hwy 70) which is very unsafe. Many people walk and run on the main road because there is no other place they can go. Surely TVA can provide this to our community to promote healthy lifestyles and give back to the local community. Please reopen this area to the public, we miss it terribly!
