

TVA, PROPOSED EASEMENT, REVISED OUTFALL ROUTE, TRM 94.3, WAVERLY, HUMPHREYS COUNTY, TENNESSEE

In a letter dated July 23, 2009 TVA consulted with the Tennessee State Historic Preservation Officer (SHPO) regarding a proposed TVA undertaking which would grant a permanent easement to the City of Waverly for a sewer line and outfall at Tennessee River mile 94.3R. The SHPO concurred with TVA's determination of no effect in a letter dated August 4, 2009. To minimize impacts to federally endangered mussels, the City of Waverly has revised the sewer line and outfall route (Figure 1). TVA identified the area of potential effects (APE) for the alternate route as the 1300-foot long by 50-foot wide pipeline corridor. Since the sewer line will be buried, there is no potential to cause a permanent, visual affect to a historic property.

In 2010, the City of Waverly contracted with Weaver & Associates, LLC to conduct an archaeological survey of the APE defined above. Enclosed are 2 copies of the draft report titled Addendum to Phase I Archaeological Assessment of 32,000 Linear Feet of Outfall Line for Sewer System Improvements for the City of Waverly, Humphreys County, Tennessee along with 1 CD containing a digital copy.

The archaeological survey identified no archaeological sites within the APE.

Pursuant to 36 CFR Part 800.3(f)(2), TVA is consulting with federally recognized Indian tribes regarding historic properties within the proposed project's APE that may be of religious and cultural significance and are eligible for the NRHP.

TVA has reviewed the enclosed report and agrees with the findings and recommendations of the authors. Pursuant to 36 CFR Part 800.4(d)(1), we are seeking your concurrence with TVA's determination of no effect to historic properties.
