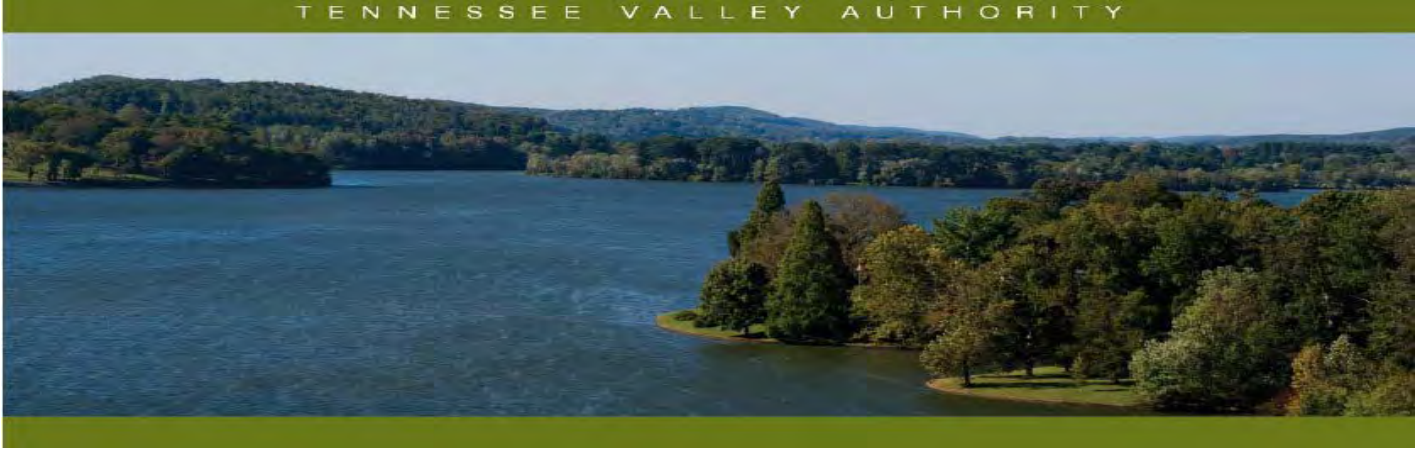

- (2) To implement TVA's [Shoreline Management Policy](#), consistent with the TVA [Land Policy](#)
- (3) To allow water-access for industrial or commercial recreation operations on private backlying property, consistent with the TVA [Land Policy](#)

Reservoir Land Planning Errors

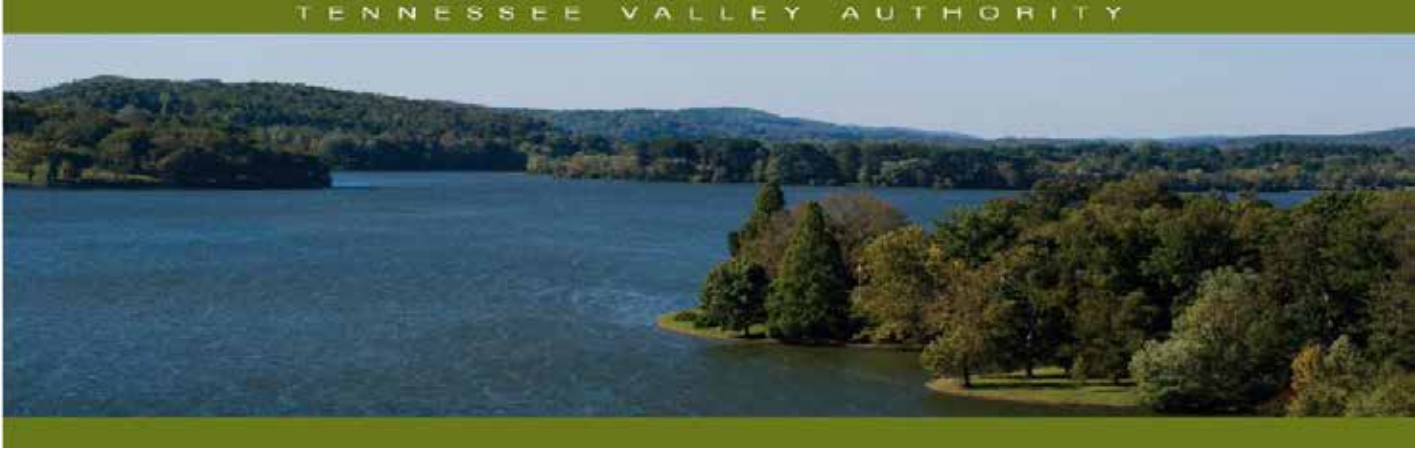
After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. Certain TVA reservoir land tracts have land management zone allocations based on the backlying land use. These zone allocations have the potential to conflict with contractual agreements that may have been misinterpreted or overlooked. The resolution of these potential conflicts has resulted in the reallocation of the TVA-managed land to align with the contractual agreement present on the property. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-6PT (Parcel 6) to correct administrative errors and is considered a supplement to the 2001 Norris RLMP. Definitions of TVA's land planning allocation zones are available at www.tva.com/landplanzones.

General Information about Norris Reservoir

Norris Reservoir is an impoundment of the Clinch River formed by Norris Dam, which is located at Clinch River mile 79.8. Norris Reservoir is situated in Anderson, Campbell, Union, Claiborne, and Grainger counties in east Tennessee. TVA originally acquired 122,000 acres of land for construction of the reservoir, which was completed in 1936. TVA has retained 27,927 acres of reservoir shore land lying above full pool elevation. At full pool, the reservoir is 129 miles long; mainland shoreline length is 809 miles; and reservoir surface area is 34,200 acres.

Norris Parcel 6 (XNR-6PT) and Parcel 6a (XNR-6aPT)

XNR-6PT (903.74 acres) is located in Anderson County along the right descending bank of Clinch River mile 80.0 on Norris Reservoir. In the 2001 Norris RLMP, XNR-6PT was allocated as Zone 2 (Project Operations) for the Norris Dam Reservation. However, a 91.64-acre portion of this parcel should have been allocated as Zone 6 (Developed Recreation) to reflect a permanent easement granted to the State of Tennessee (XNR-125RE) for Norris Dam State Park. (The remaining 83.5 acres of TVA land included in the permanent easement for Norris Dam State Park is included as XNR-8PT (Parcel 8) and is allocated as "Developed Recreation.") The 91.64-acre portion of the 903.74-acre parcel has been modified as new Parcel 6a (XNR-6aPT) and the allocation has changed from "Project Operations" to "Developed Recreation." New Parcel 6a has approximately 6,700 linear feet of shoreline and the "Developed Recreation" allocation reflects the existing permanent easement for Norris Dam State Park. Further, a 7.38-acre area of inundated reservoir property was mistakenly included in the Parcel 6 acreage and has been removed. Parcel 6 acreage has changed from 903.74 acres to 804.72 acres and continues to be allocated as "Project Operations."

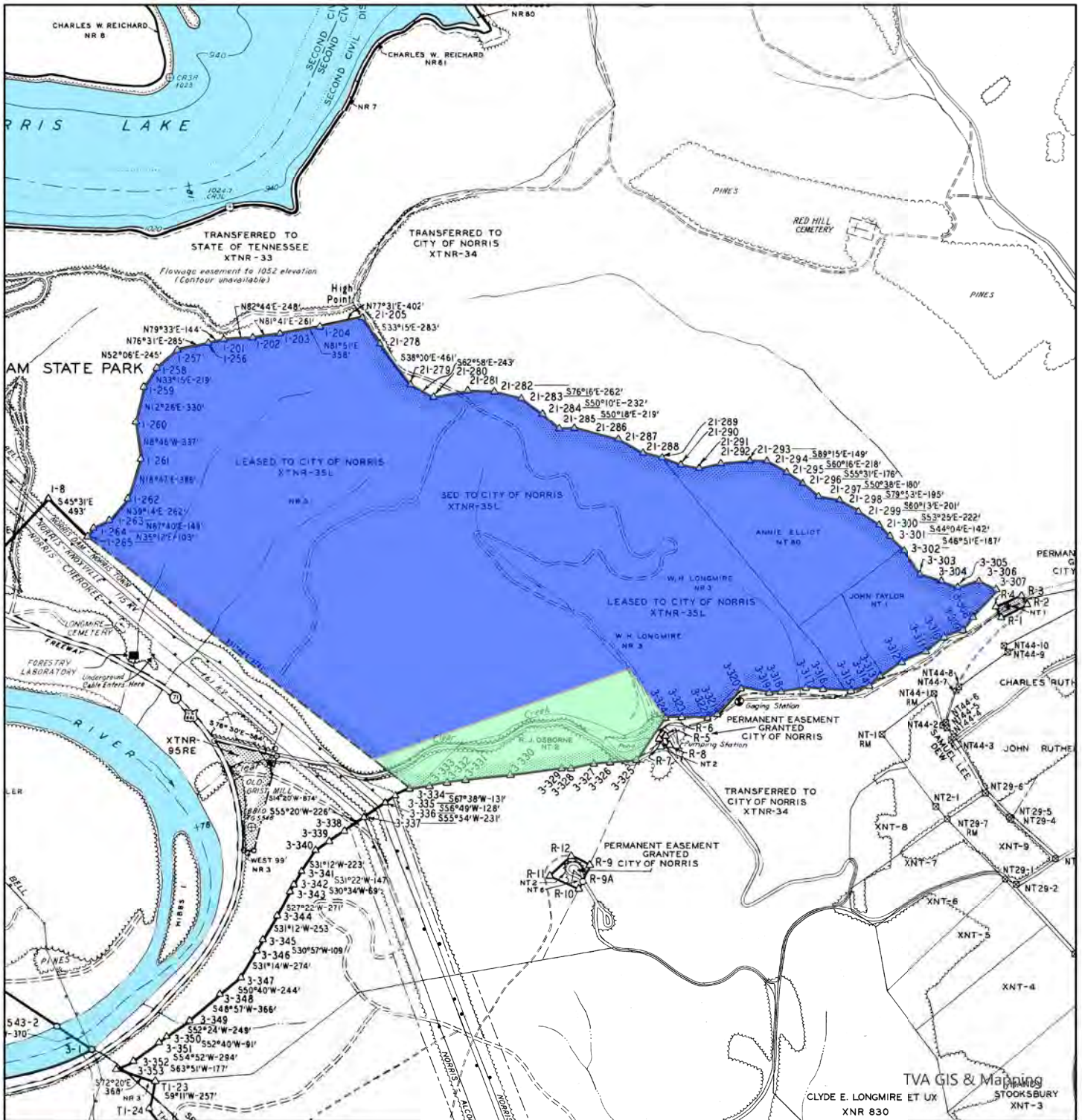
After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. Former TVA reservoir property reverts to Zone 1 (Non-TVA Shoreland). This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-7PT no longer in TVA's ownership and is considered a supplement to the 2001 Norris RLMP. TVA originally acquired 122,000 acres of land for construction of the reservoir, which was completed in 1936. TVA has retained 27,927 acres of reservoir shore land lying above full pool elevation. At full pool, the reservoir is 129 miles long; mainland shoreline length is 809 miles; and reservoir surface area is 34,200 acres.

Norris Parcel 7 (XNR-7PT)

XNR-7PT (456.49 acres) is located in Anderson County, Tennessee along the left bank between Clinch River miles 78 and 81. In the 2001 Norris RLMP, XNR-7PT is allocated for Zone 4 (Natural Resource Conservation). However, TVA transferred approximately 423.89 acres of that land in 2006 to the State of Tennessee. TVA reallocated the transferred land to Zone 1 (Non-TVA Shoreland) to reflect the change in ownership. The remainder of XNR-7PT (32.6 acres) continues to be allocated as Zone 4 (Natural Resource Conservation).

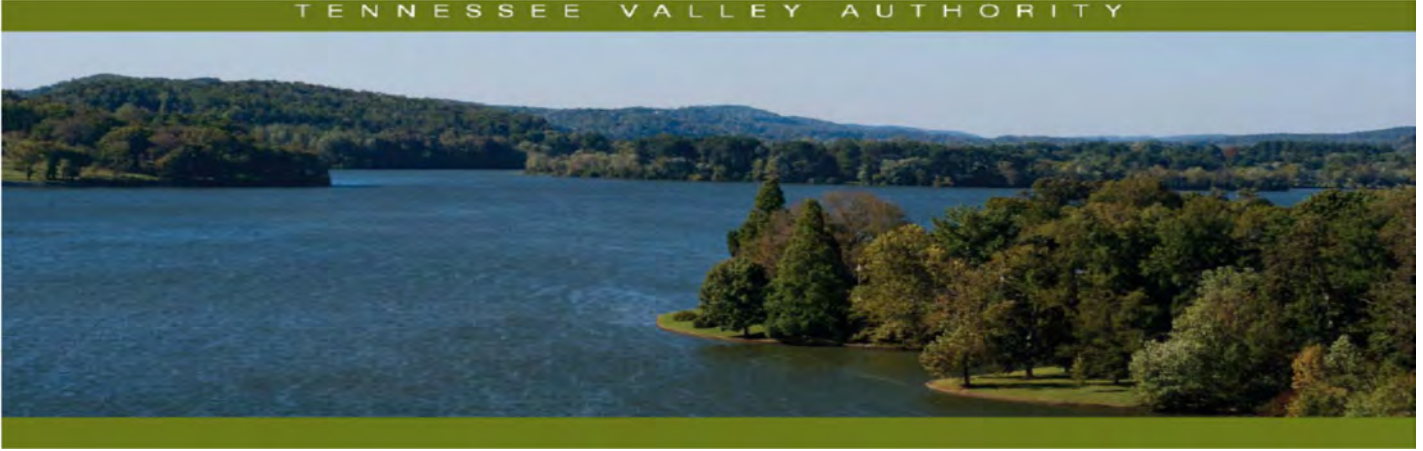

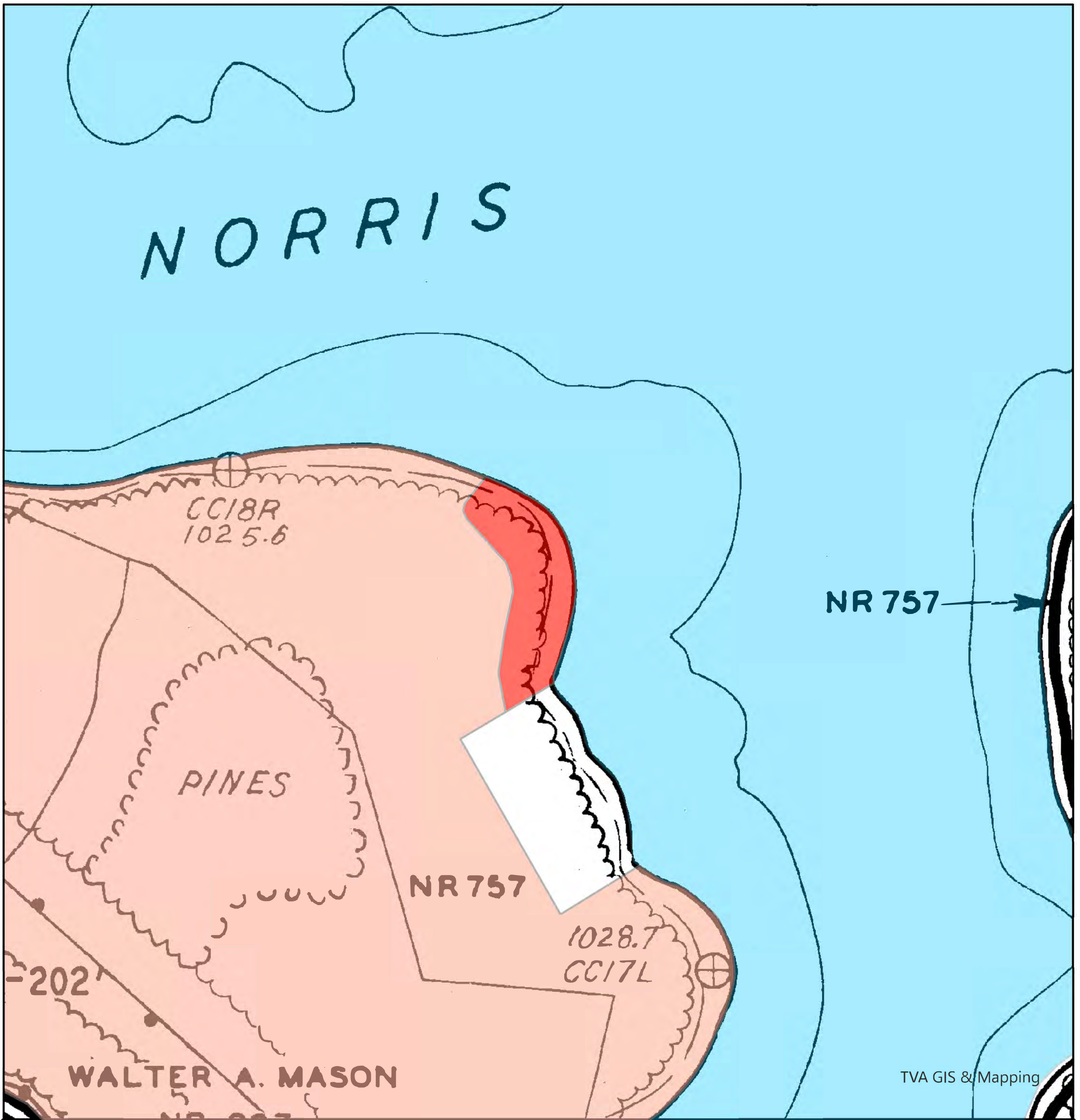
After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. However, legal or mapping errors found after the approval of a RLMP often need to be addressed when identified. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-10PT (XNR-10aPT) and is considered a supplement to the 2001 Norris RLMP. General Information about Norris Reservoir

Norris Reservoir is an impoundment of the Clinch River formed by Norris Dam, which is located at Clinch River mile 79.8. Norris Reservoir is situated in Anderson, Campbell, Union, Claiborne, and Grainger counties in east Tennessee. TVA originally acquired 122,000 acres of land for construction of the reservoir, which was completed in 1936. TVA has retained 27,927 acres of reservoir shore land lying above full pool elevation. At full pool, the reservoir is 129 miles long; mainland shoreline length is 809 miles; and reservoir surface area is 34,200 acres.

Norris Parcel 10PT (XNR-10PT)

XNR-10PT (73.81 acres) is located in Campbell County along the right descending bank of Cove Creek mile 5.2 on Norris Reservoir. In the 2001 Norris RLMP, XNR-10PT was allocated as Sensitive Resource Management (Zone 3) for cultural resources, sensitive plant species and the Oak Grove River Bluffs TVA Habitat Protection Area. However, a portion of XNR-10PT occupies the area of a public launching ramp access area that was in existence prior to the approval of the 2001 Norris RLMP. In order to resolve the potential land use conflict with the "Sensitive Resource Management" allocation, a 1.43-acre portion of the parcel has been reallocated to Developed Recreation (Zone 6) and renamed XNR-10aPT. Requests for public recreation agreements and associated water-use facilities would be considered on XNR-10aPT. The remainder of XNR-10PT (72.38 acres) remains allocated as "Sensitive Resource Management."



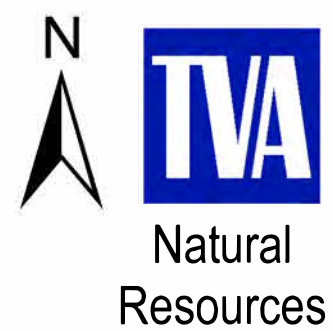

Proposed Allocation Change Campbell County, Tennessee XNR-10PT Cove Creek 5.2R

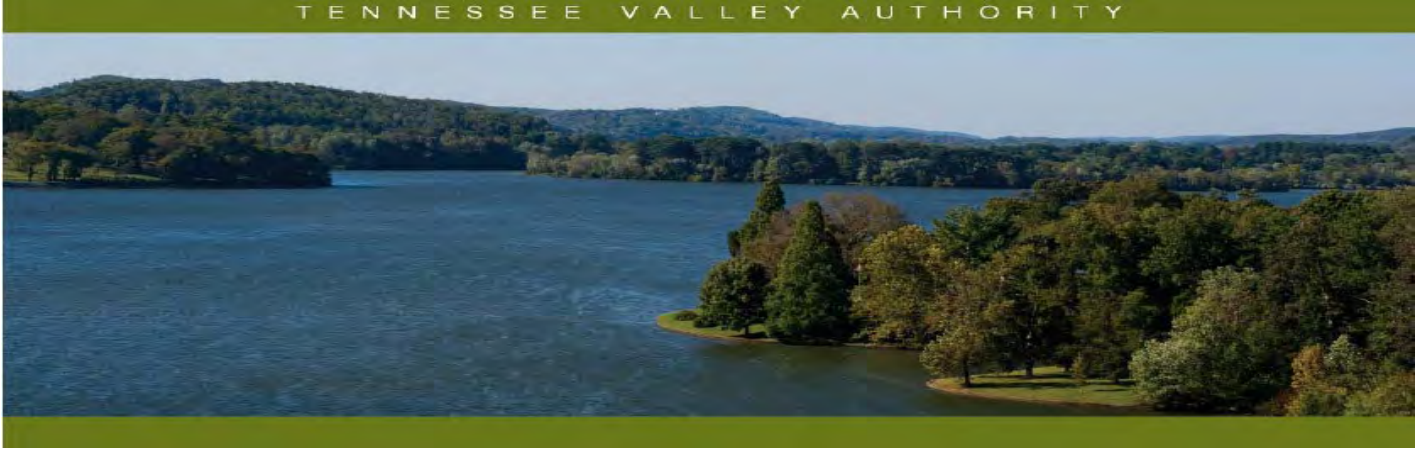

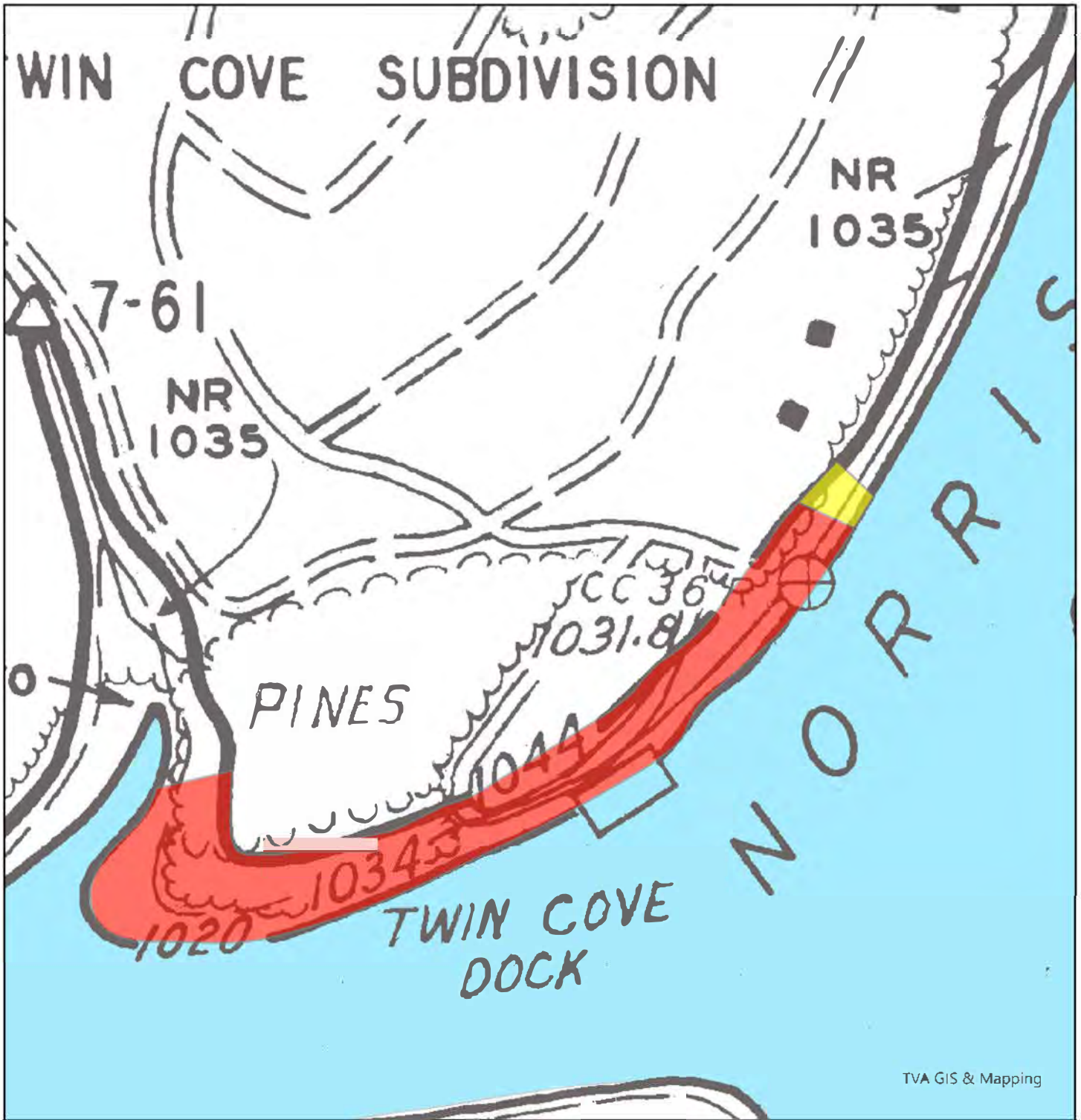

Certain TVA reservoir land tracts have land management zone allocations based on the backlying land use. These zone allocations have the potential to conflict with egress and ingress rights of the adjacent property owners if the backlying land use were to change. The resolution of these potential conflicts has resulted in the reallocation of the TVA-managed land to align with the egress and ingress rights of the adjacent property owners. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-21PT (XNR-21aPT) and is considered a supplement to the 2001 Norris RLMP. Norris Parcel 21 (XNR-21PT), Parcel 21a (XNR-21aPT)

XNR-21PT (3.11 acres) is located in Campbell County, Tennessee along the right bank at Cove Creek mile 12.1. In the 2001 Norris RLMP, XNR-21PT is allocated for Zone 6 (Developed Recreation). A portion of XNR-21PT is currently under license for commercial recreation. XNR-21PT fronts a tract of former TVA land, XNR-637, which TVA sold subject to Section 31 of the TVA Act of 1933. In the deed, TVA granted the owners the right of ingress and egress to and from the waters of Norris Lake for the purposes of constructing and maintaining water use facilities. A 0.12-acre portion of this land is not associated with the commercial recreation area, and there is a pending request for a private water-use facility. In order to resolve the potential conflicts from the 2001 RLMP allocations which do not allow for private water use facilities, a 0.12-acre portion of XNR-21PT was reallocated to "Residential Access" and designated as Parcel 21a (XNR-21aPT). XNR-21PT now consists of 2.99 acres and remains allocated as "Developed Recreation."

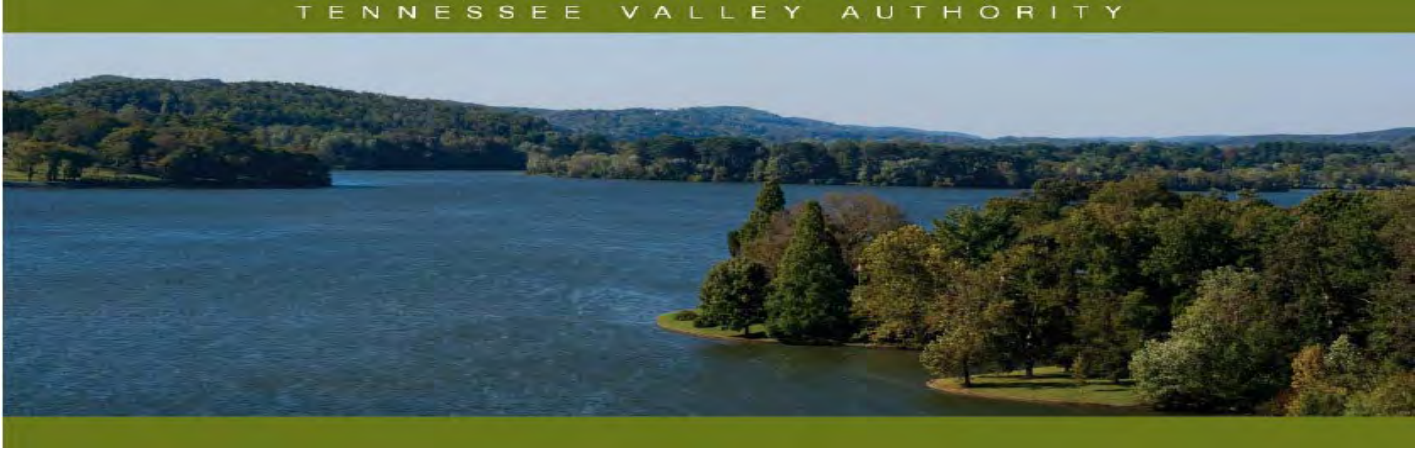

After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. Certain TVA reservoir land tracts have land management zone based on the backlying land use. These zone allocations have the potential to conflict with ingress and egress rights of the adjacent property owners if the backlying land use were to change. The resolution of these potential conflicts has resulted in the reallocation of the TVA-managed land to align with the ingress and egress rights of the adjacent property owners. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-66PT (XNR-66aPT) and is considered a supplement to the 2001 Norris RLMP. Definitions of TVA's land planning allocation zones are available at www.tva.com/landplanzones.

Norris Parcel 66PT (XNR-66PT)

XNR-66PT (6.97 acres) is located in Campbell County along the left descending bank of Big Creek mile 8.5 on Norris Reservoir. In the 2001 Norris RLMP, XNR-66PT was allocated as Developed Recreation (Zone 6) for an existing commercial marina. However, a portion of XNR-66PT fronts a residential area, part of former TVA tract XNR-655, which TVA sold subject to Section 31 of the TVA Act of 1933. In the deed, TVA granted the owners the right of ingress and egress rights to and from the waters of Norris Lake over and upon the adjoining land lying between the 1044-foot contour elevation and the waters of the lake, and the deed does not contain any restrictions otherwise limiting those rights. In order to resolve the potential land use conflict with the "Developed Recreation" allocation, a 1.17-acre portion of the 6.97-acre parcel has been reallocated to "Shoreline Access" (Zone 7) and renamed XNR-66aPT. Requests for private water use facilities would be considered on XNR-66aPT. The remainder of XNR-66PT (5.8 acres) remains allocated as "Developed Recreation."

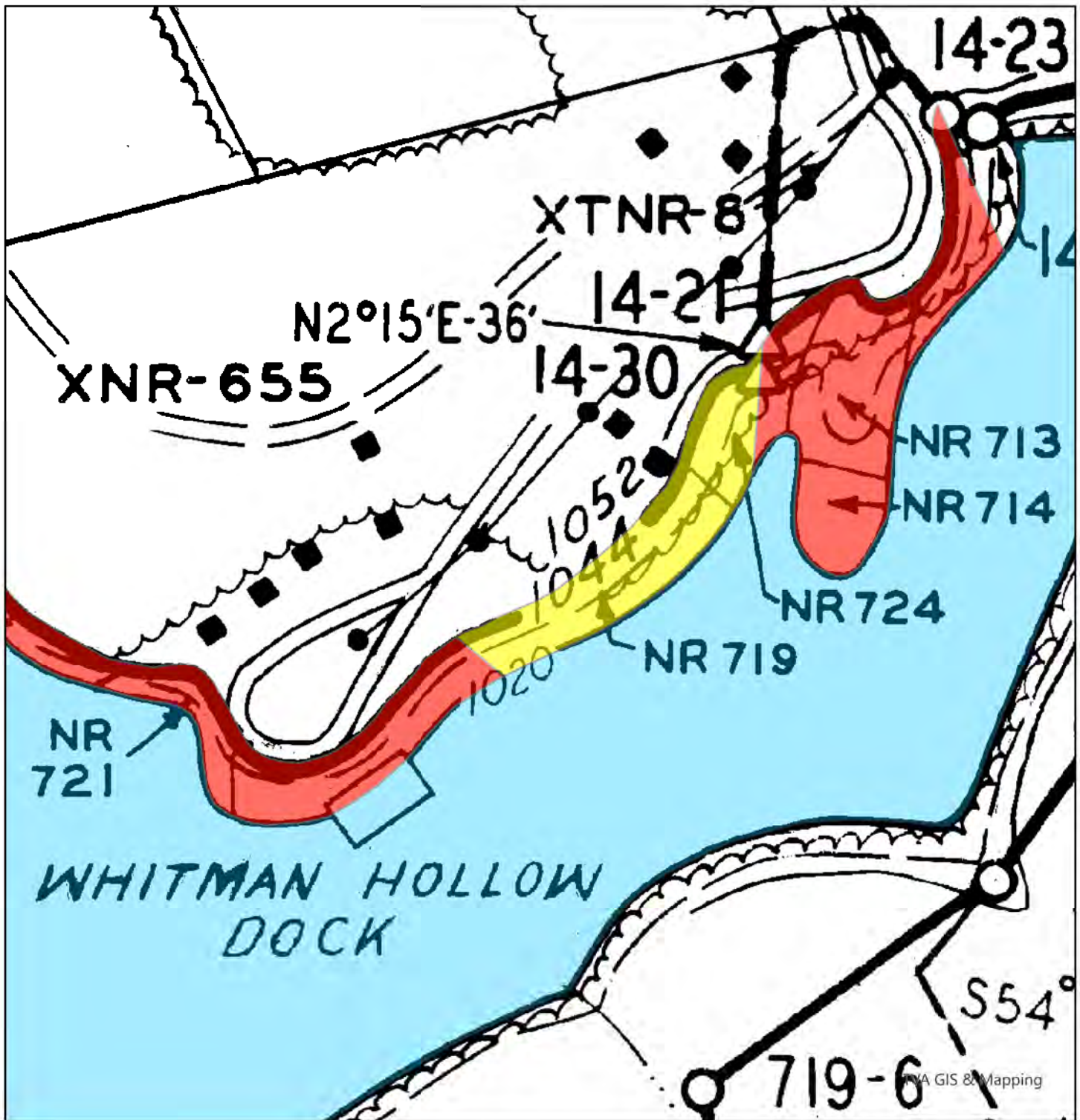
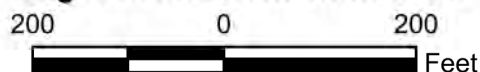

Big Creek River Mile 8.5L



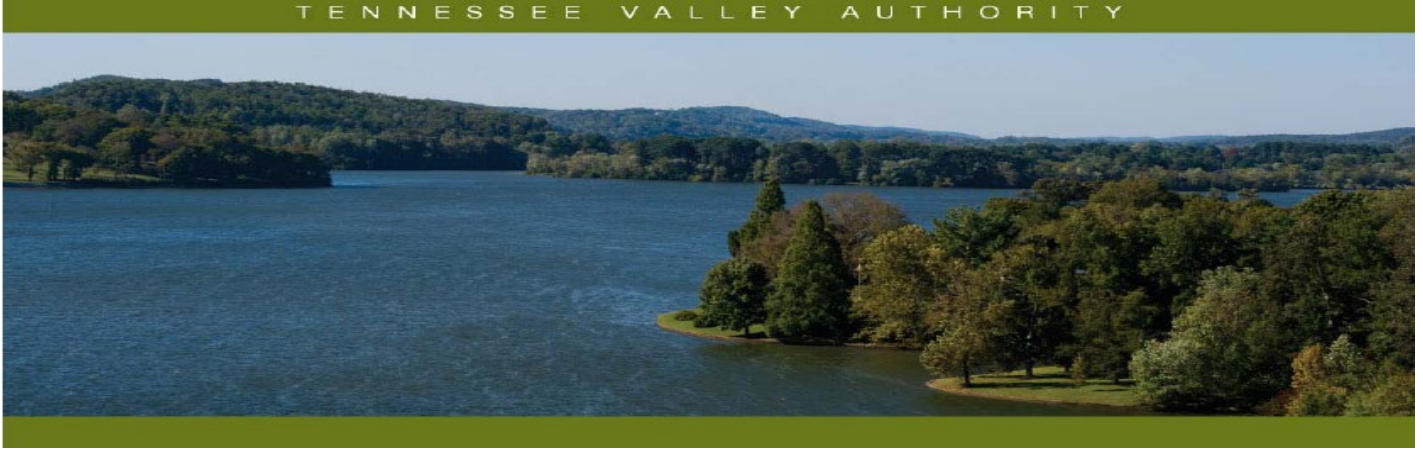

Reservoir Land Planning Allocation Change

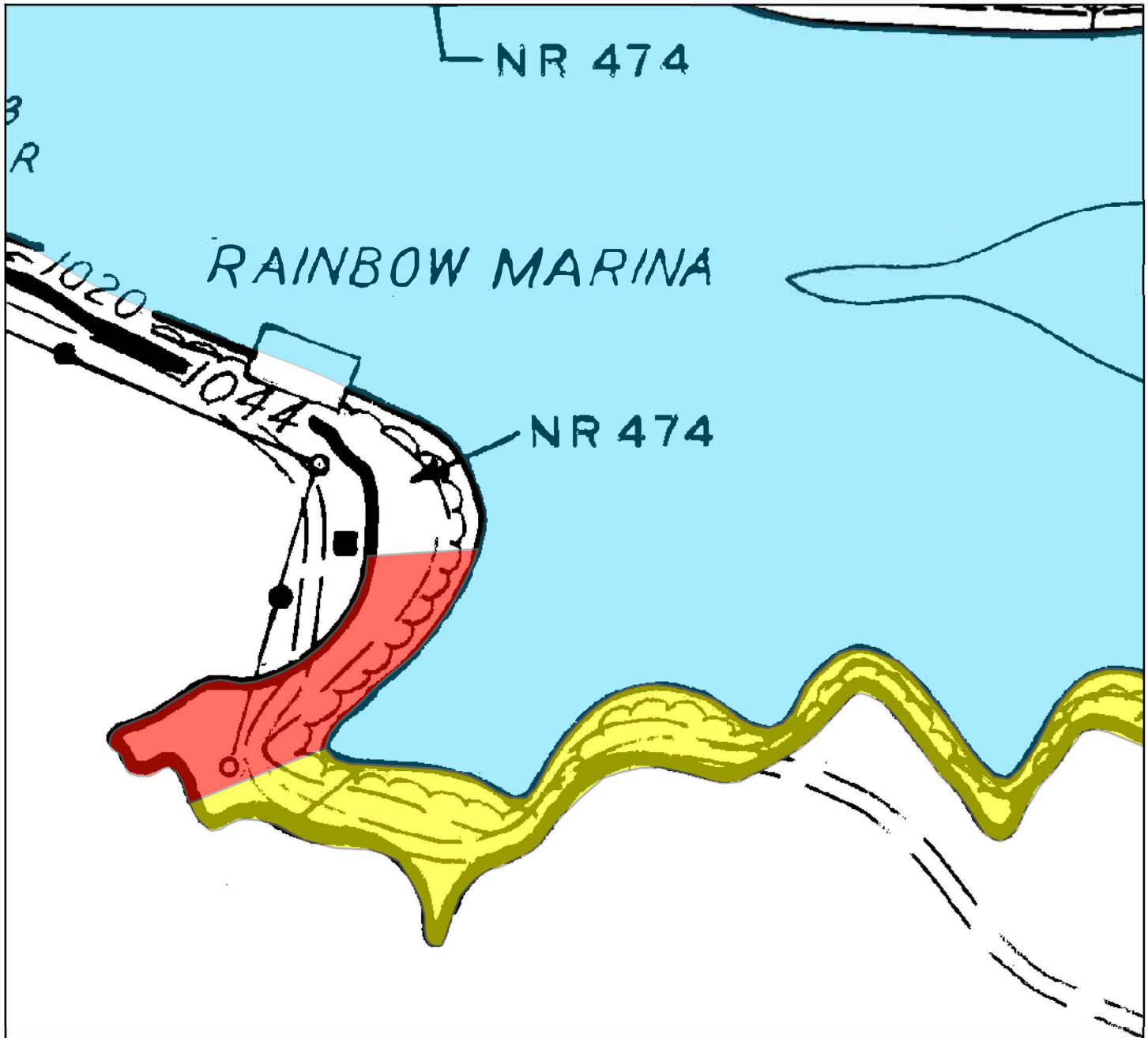
After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. Pursuant to TVA's Land Policy, TVA shall consider changing a land use designation outside of the normal planning process only for water access purposes for industrial or commercial recreation operations on privately owned backlying land. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-79PT (XNR-79aPT) and is considered a supplement to the 2001 Norris RLMP. Norris Parcel 79PT (XNR-79PT)

XNR-79PT (29.11 acres) is located in Campbell County along the right descending bank of the Clinch River mile 88.2 on Norris Reservoir. In the 2001 Norris RLMP, XNR-79PT was allocated as Zone 7 (Residential Access). However, the backlying private property owner has requested Section 26a approval for a commercial recreation water-use facility on the TVA land fronting a portion of this property, adjacent to their existing commercial recreation operation. To allow consideration of this request, the allocation first has to be changed from Zone 7 (Residential Access), to Zone 6 (Developed Recreation). After appropriate review, a 1.27-acre portion of the parcel has been reallocated to Zone 6 (Developed Recreation) and renamed XNR-79aPT. Requests for commercial recreation agreements and associated water-use facilities would be considered on XNR-79aPT. The remainder of XNR-79PT (27.84 acres) remains allocated as Zone 7 (Residential Access).

Certain TVA reservoir land tracts have land management zone allocations based on the backlying land use. These zone allocations have the potential to conflict with egress and ingress rights of the adjacent property owners if the back-lying land use were to change. The resolution of these potential conflicts has resulted in the reallocation of the TVA-managed land to align with the egress and ingress rights of the adjacent property owners. This document addresses the reallocation of a portion of Norris RLMP Plan Tract No. XNR-80PT (Parcel 80) and is considered a supplement to the 2001 Norris RLMP. Definitions of TVA's land use zone allocations are available at www.tva.com/landplanzones.

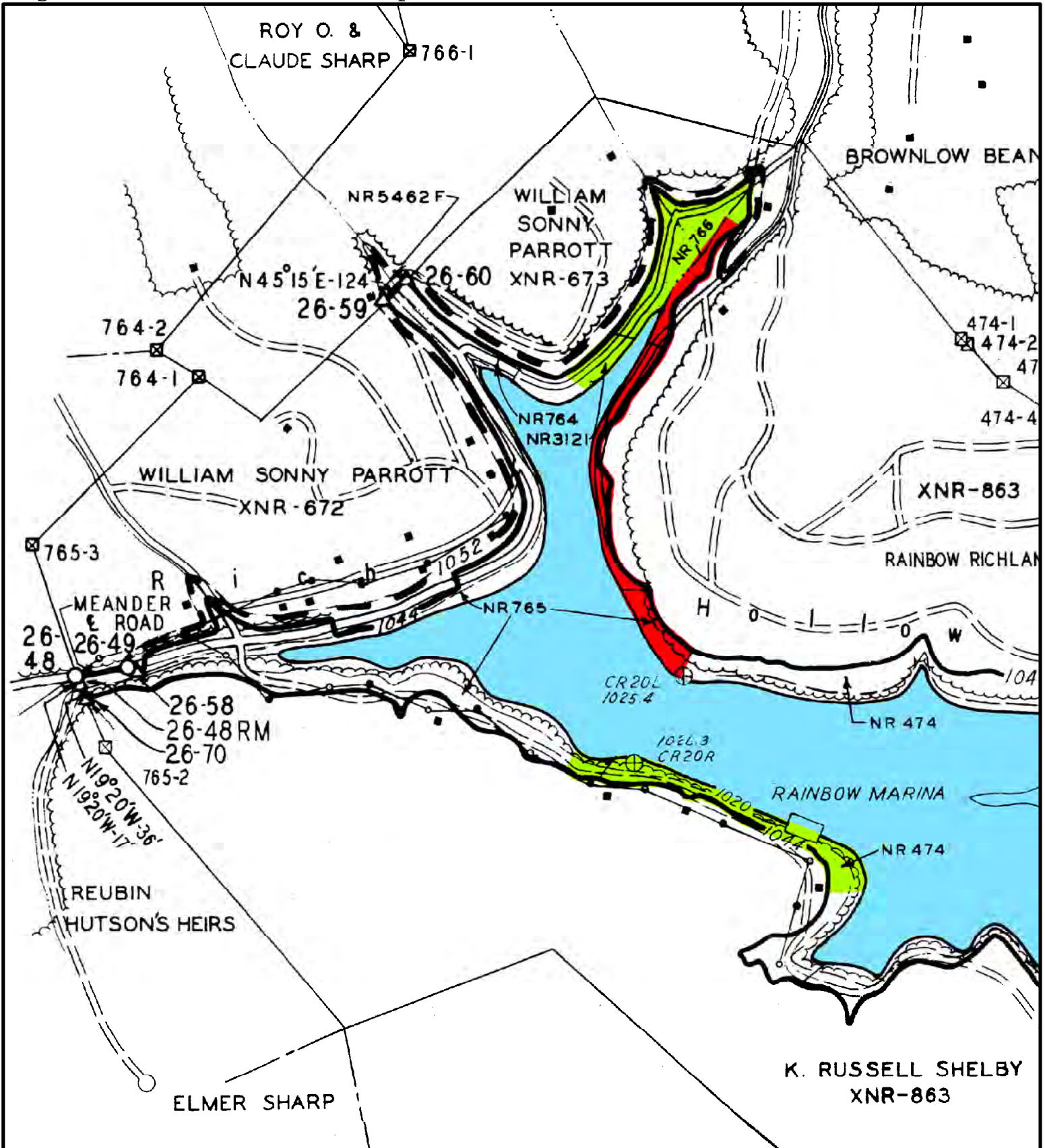
General Information about Norris Reservoir

Norris Reservoir is an impoundment of the Clinch River formed by Norris Dam, which is located at Clinch River mile (CRM) 79.8. Norris Reservoir is located in the Tennessee counties of Anderson, Campbell, Claiborne, Grainger, and Union. TVA originally acquired 122,000 acres of land for construction of the reservoir, which was completed in 1936. TVA has retained 27,927 acres of land lying above full pool elevation. At full pool, the reservoir is 129 miles long; mainland shoreline length is 809 miles; and surface area is 34,200 acres.

Norris Parcel 80 (XNR-80PT) and Parcel 80a (XNR-80aPT)

XNR-80PT (8.23 acres) is located in Campbell County, Tennessee, along the right descending bank of CRM 88.2. In the 2001 RLMP, XNR-80PT is allocated as Zone 6 (Developed Recreation). However, a portion of XNR-80PT fronts a parcel of former TVA land, XNR-863, which TVA sold subject to Sections 4(k)(a) and 31 of the TVA Act. Upon the sale of these lands, TVA granted the "right of ingress and egress over the adjoining land lying between the 1044-foot contour elevation and the waters of the lake." This former TVA land is now used for residential purposes. In accordance with TVA's Shoreline Management Policy, former TVA land encumbered with certain deeded access rights may be used for residential shoreline access. The access rights in the deed combined with the residential land use warrants an allocation change to reflect shoreline access rights. In order to resolve the potential conflict of the allocation for "Developed Recreation," XNR-80PT is modified to consist of new XNR-80aPT (2.85 acres) and XNR-80PT acreage changed to 5.37 acres and remains allocated as "Developed Recreation" (see Exhibit Map). XNR-80aPT (Parcel 80a) fronts Rainbow Richland Subdivision and occupies approximately 1,575 feet of shoreline. XNR-80aPT is now allocated as Zone 7 (Shoreline Access) and requests for private water use facilities will be considered for this parcel.

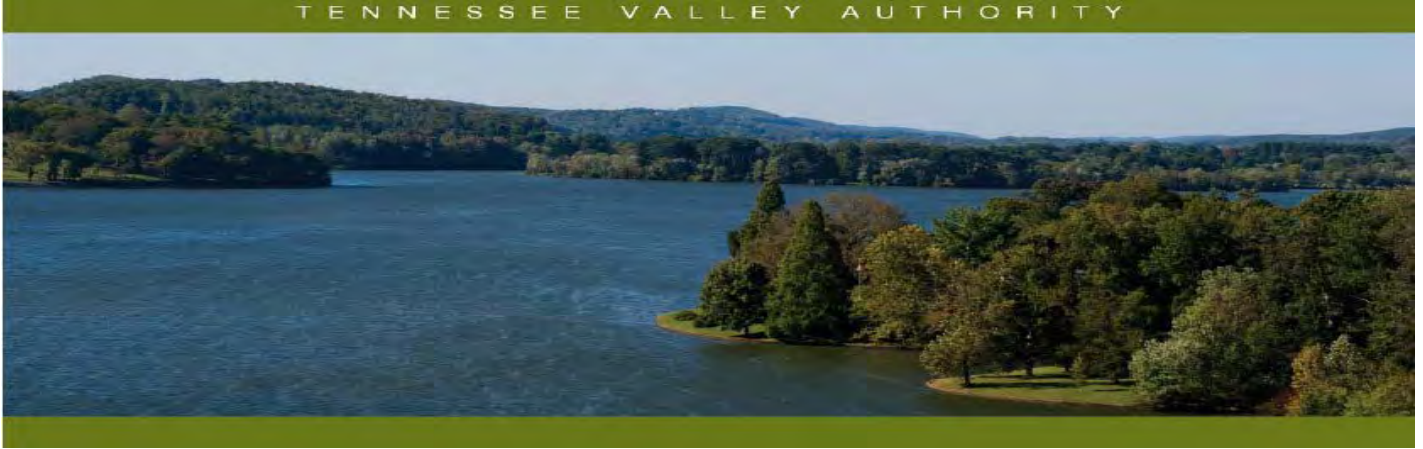

Reservoir Lands Planning Allocation Change

After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. TVA has determined that a portion of Parcel 80 (Plan Tract No. XNR-80PT) qualifies for an allocation change due to a change in the backlying land use and existing ingress and egress rights. Certain TVA reservoir parcels are allocated to land use zones based on the backlying land use, and in the case of Parcel 80, it was allocated as Zone 6 (Developed Recreation) in the 2001 Norris RLMP for an existing commercial marina. In some areas, the backlying land use has changed to residential and the “Developed Recreation” allocation conflicts with some areas with ingress and egress rights of the adjacent property owners. This document addresses the reallocation of a 1.0-acre portion of XNR-80PT to Zone 7 (Shoreline Access) and is considered a supplement to the 2001 Norris RLMP. Norris Parcel 80 (XNR-80PT) and new Parcel 80b (XNR-80bPT)

XNR-80PT (8.2 acres) is located in Campbell County along the left descending bank of Clinch River mile 88.2 on Norris Reservoir. In the 2001 Norris RLMP, Parcel 80 was allocated as “Developed Recreation” and is described as predominately wooded. Since 2001, XNR-80PT acreage has changed from 8.2 acres to 5.4 acres due to an allocation change to “Shoreline Access” on a 2.8-acre portion (Parcel 80a) in 2012. A 1.0-acre portion that fronts a tract of former TVA property, XNR-863, which TVA sold subject to Section 31 of the TVA Act of 1933 qualifies for an allocation change to “Shoreline Access.” In the deed, TVA granted the owners the right of ingress and egress rights to and from the waters of Norris Lake over and upon the adjoining land lying between the 1044-foot contour elevation and the waters of the lake, and the deed does not contain any restrictions otherwise limiting those rights. A 1.0-acre portion of Parcel 80 has been re-designated as new Parcel 80b (XNR-80bPT) and the land use allocation changes to “Shoreline Access.” Parcel 80b has approximately 480 linear feet of shoreline and the “Shoreline Access” allocation reflects the deeded access rights of ingress and egress across TVA shoreline property of the backlying property owners. Requests for private water use facilities would be considered on XNR-80bPT. The remaining 4.4 acres of XNR-80PT remains allocated as “Developed Recreation.”

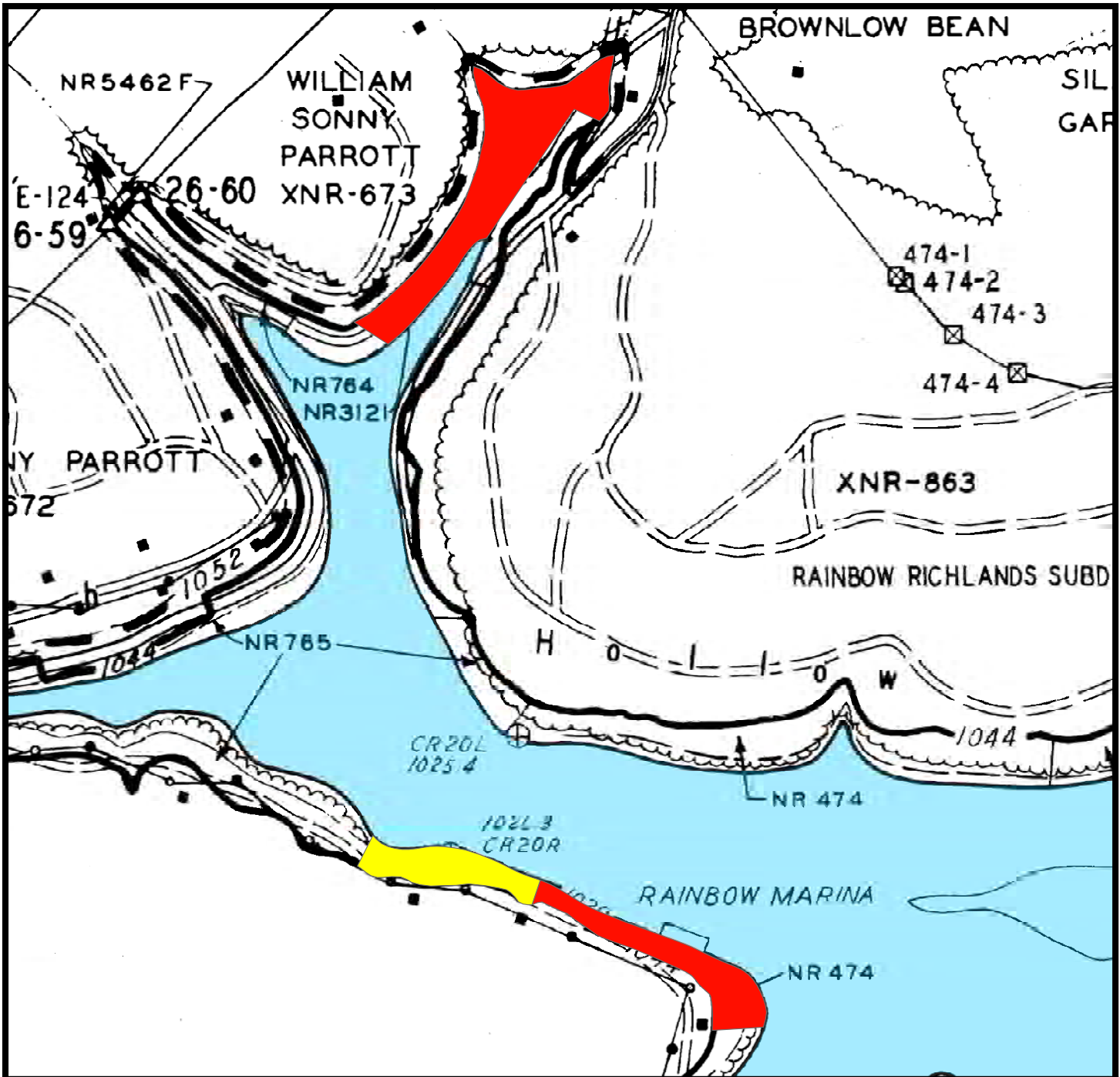

- XNR-80PT - Area to Remain as Zone 6 (Approx. 4.34 acres)

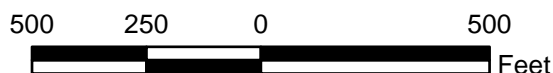

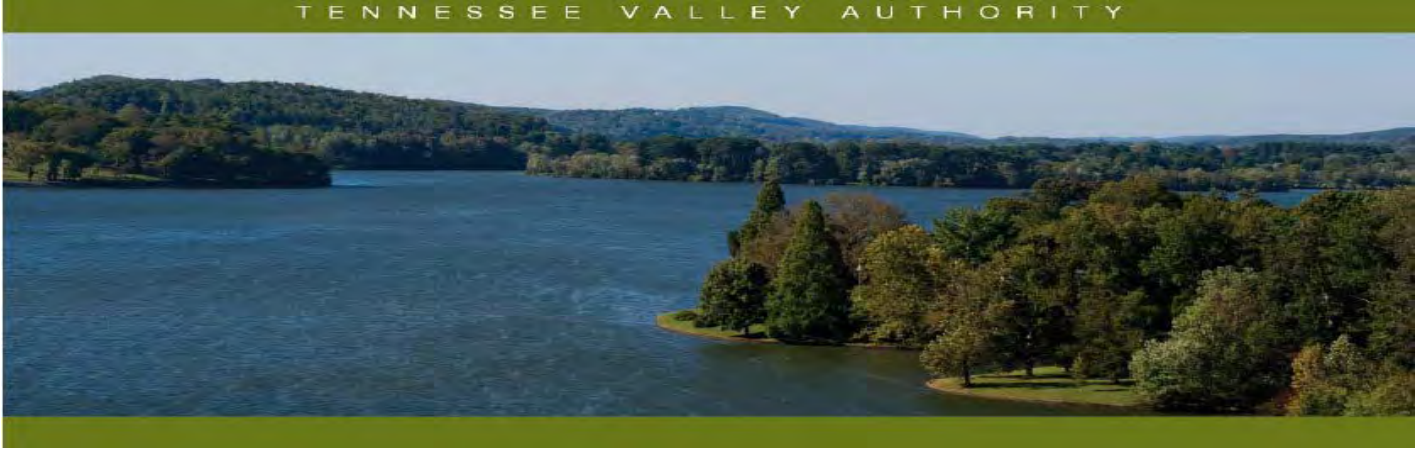

XNR-121aPT has approximately 1,396 linear feet of shoreline and allocation to "Shoreline Access" reflects the deeded access rights of ingress and egress across TVA shoreline property of the backlying property owner. Requests for private water use facilities would be considered on XNR-121aPT. XNR-121PT consists of the remainder of the original reservoir land tract (2,140.80 acres) and remains allocated as "Natural Resource Conservation."

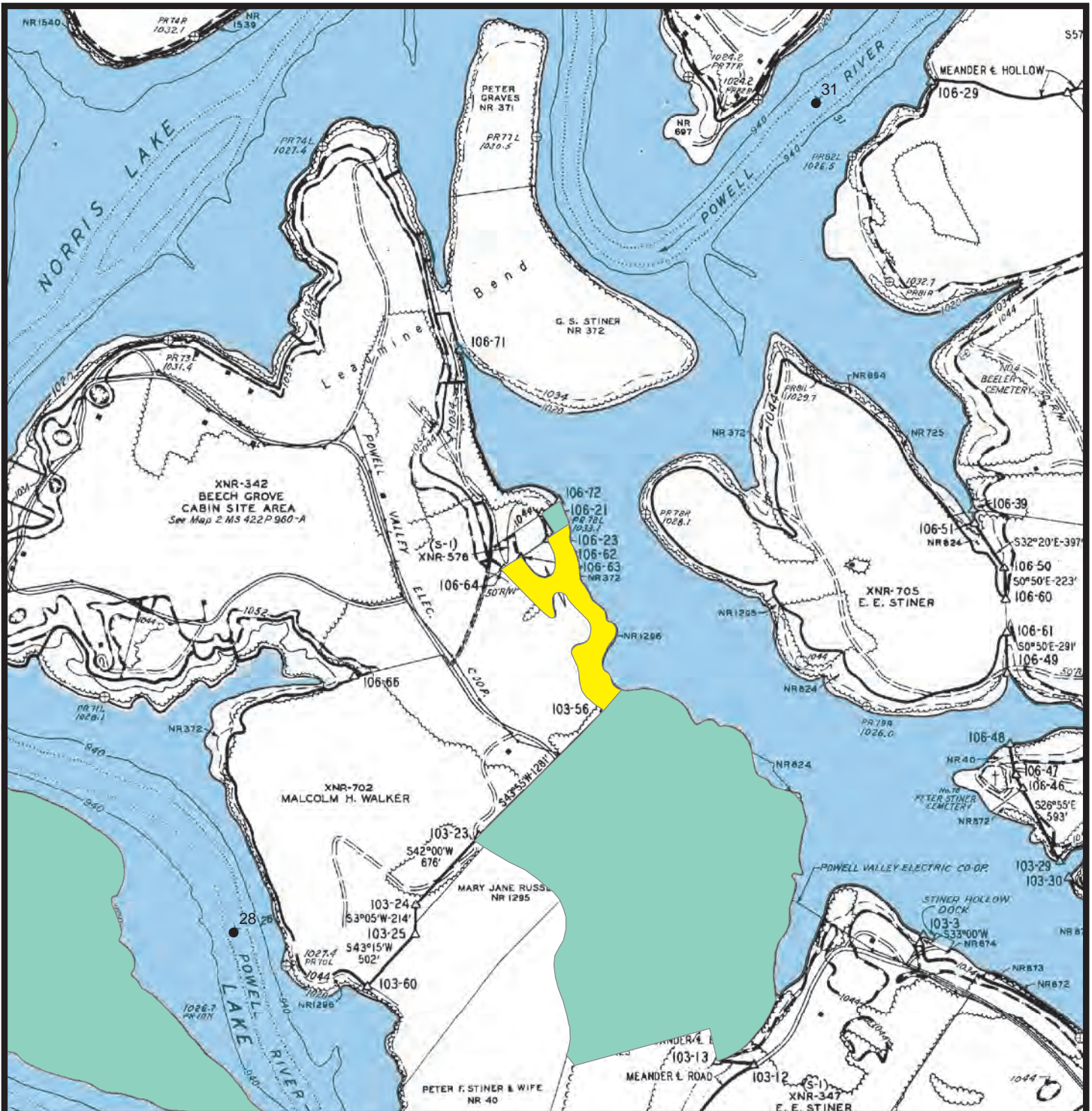

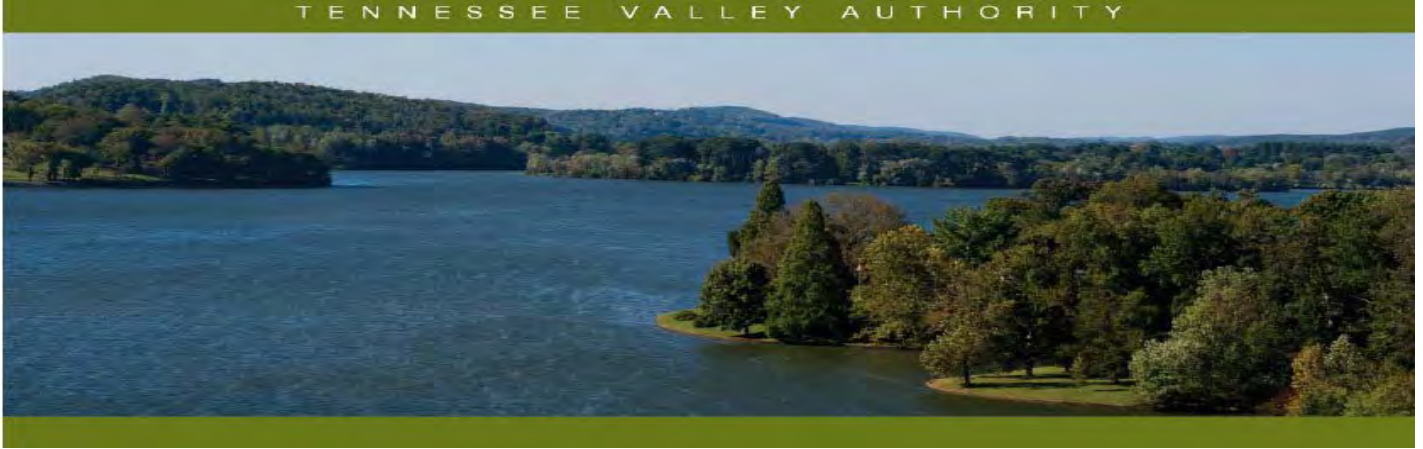

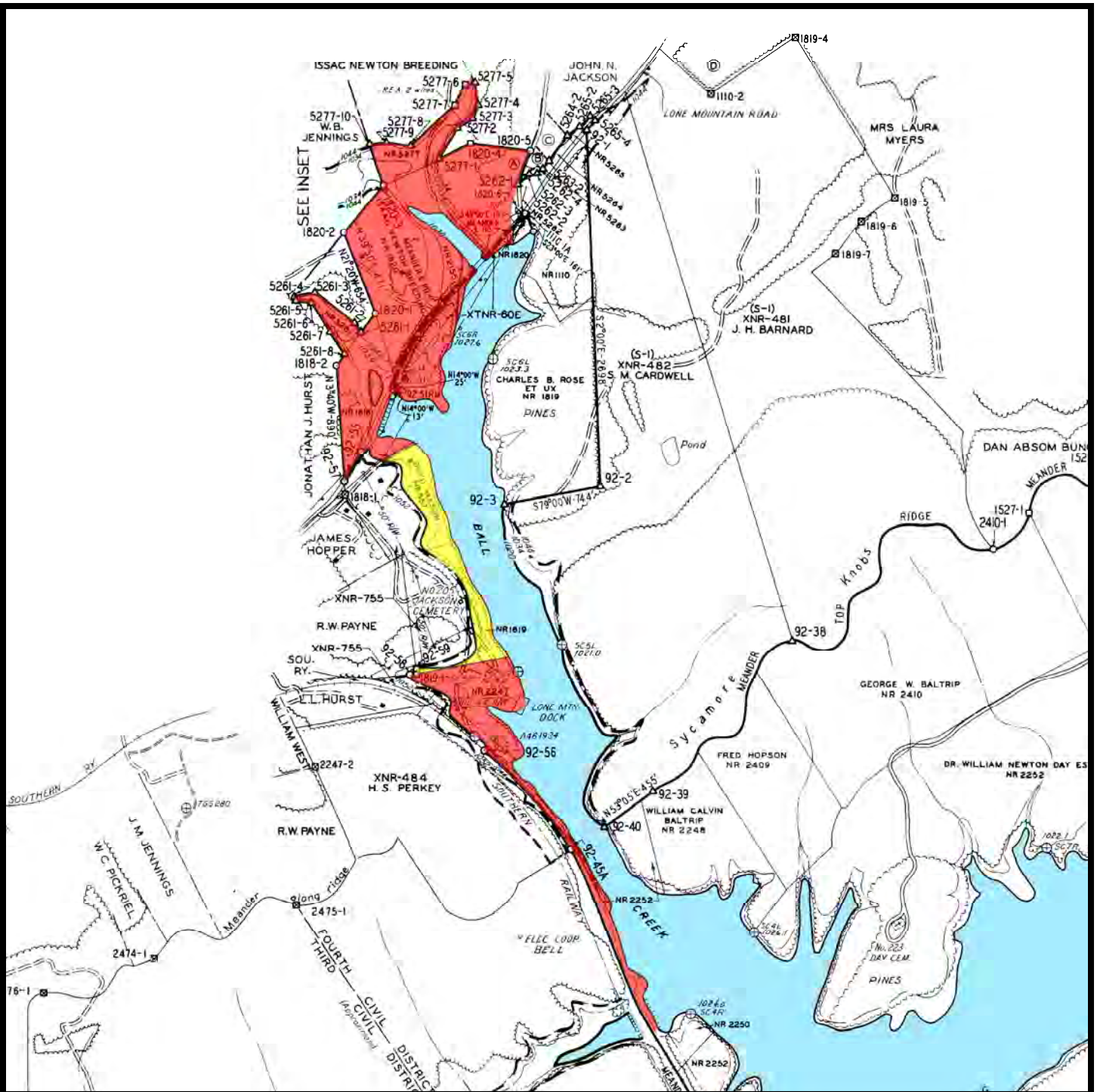

Land Use Allocation Change XNR-209PT and XNR-209aPT Claiborne County, Tennessee Ball Creek Mile 2.0R

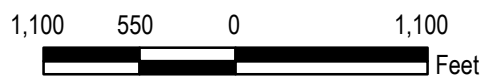

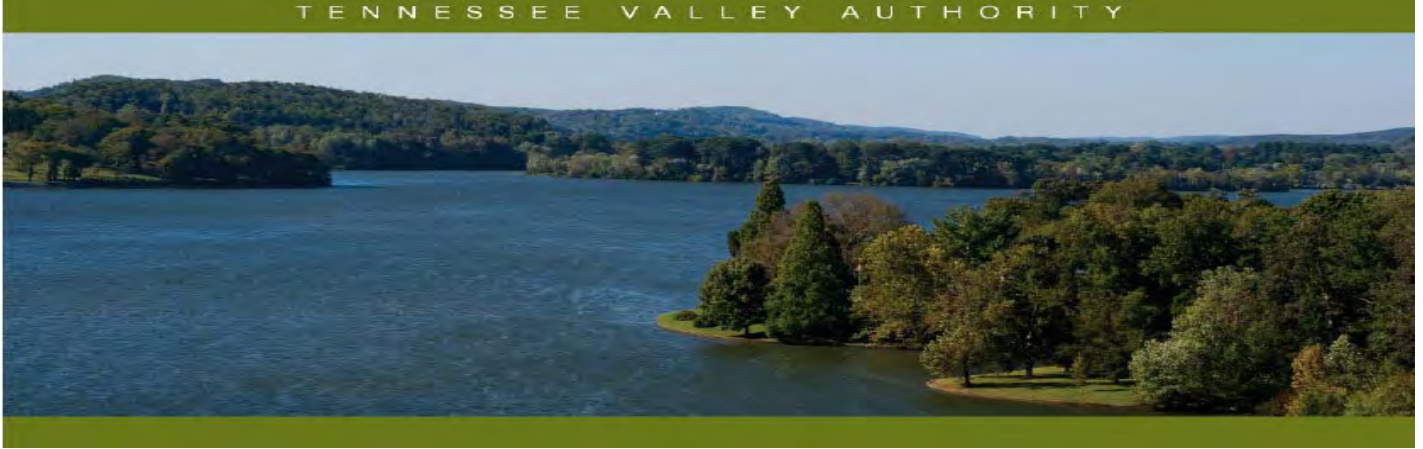

Norris Reservoir is situated in Anderson, Campbell, Union, Claiborne, and Grainger counties in east Tennessee. TVA originally acquired 122,000 acres of land for construction of the reservoir, which was completed in 1936. TVA has retained 27,927 acres of reservoir shore land lying above full pool elevation. At full pool, the reservoir is 129 miles long; mainland shoreline length is 809 miles; and reservoir surface area is 34,200 acres.

Norris Parcel 310a and Parcel 310b

Norris shoreland adjacent to TVA sale tract XNR-15 was allocated for Zone 1 (Non-TVA Shoreland) in the 2001 Norris RLMP. XNR-15 was sold at auction by TVA in 1953 as individual lots of Pellissippi Point Subdivision. Although most lots in Pellissippi Point Subdivision were sold to the 1020-foot contour (i.e., the shoreline of Norris Reservoir), some lots were sold to the 1034-foot contour. All lots have the necessary rights of ingress and egress for the ability to request water-use facilities, but there is a strip of TVA land fronting a small number of lots. In order to rectify this error and to ensure public awareness of the TVA land in these locations to prevent violations and encroachments, TVA has reallocated lands from Zone 1 to Zone 7 (Shoreline Access) where fronting residential areas and from Zone 1 to Zone 6 (Developed Recreation) where fronting commercial recreation areas. Therefore, a 3.1-acre area (TVA Tract No. XNR-310aPT) has been reallocated from Zone 1 to Zone 7 (Shoreline Access) and a 0.13-acre area (TVA Tract No. XNR-310bPT) has been reallocated from Zone 1 to Zone 6 (Developed Recreation). The remainder of the area fronting the XNR-15 sale tract is still allocated as Zone 1 (Non-TVA Shoreland). Requests for private water-use facilities can be considered fronting the Zone 1 and Zone 7 allocations. Requests supporting recreational use (commercial or public) can be considered fronting the Zone 6 allocation.

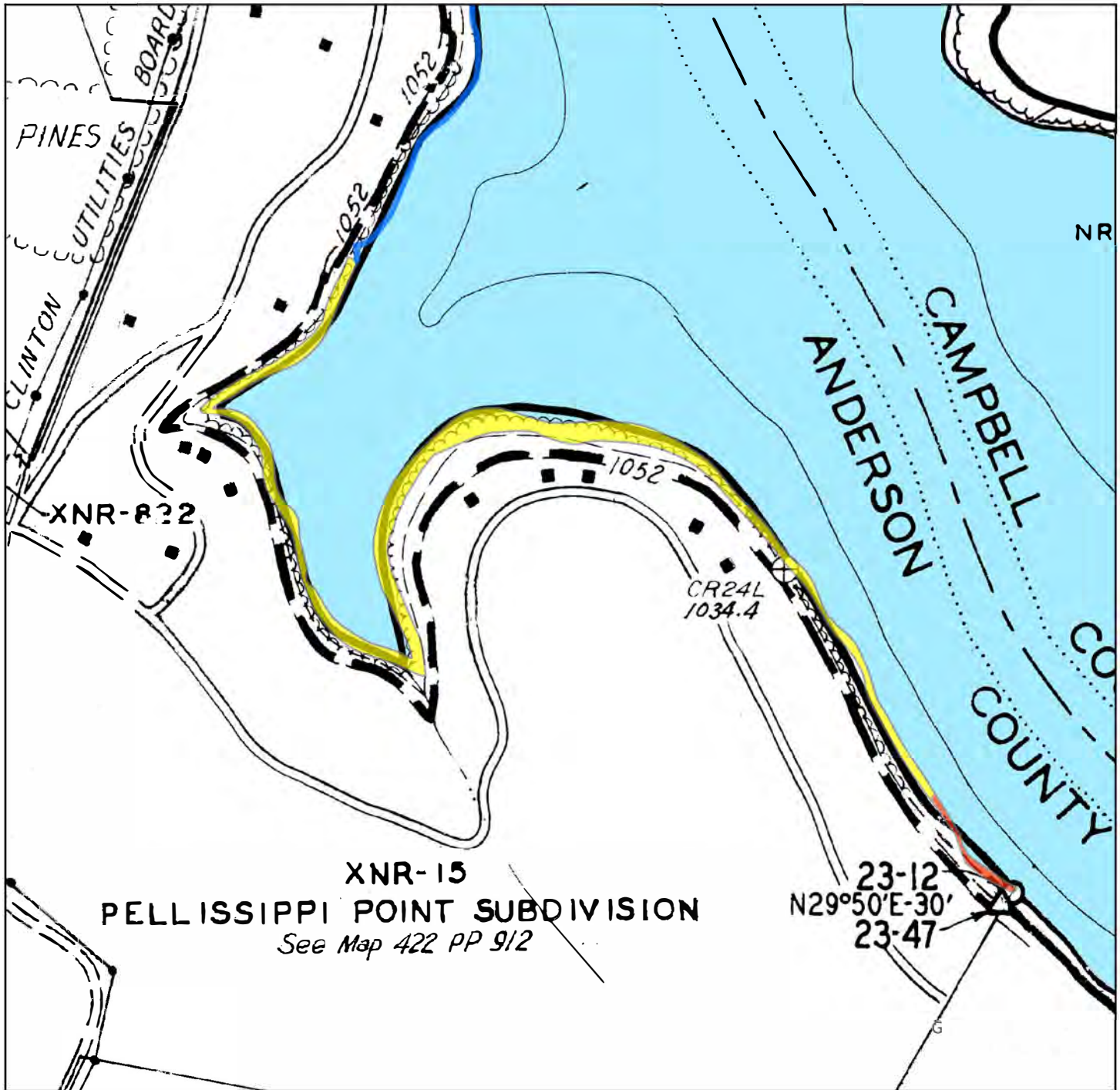



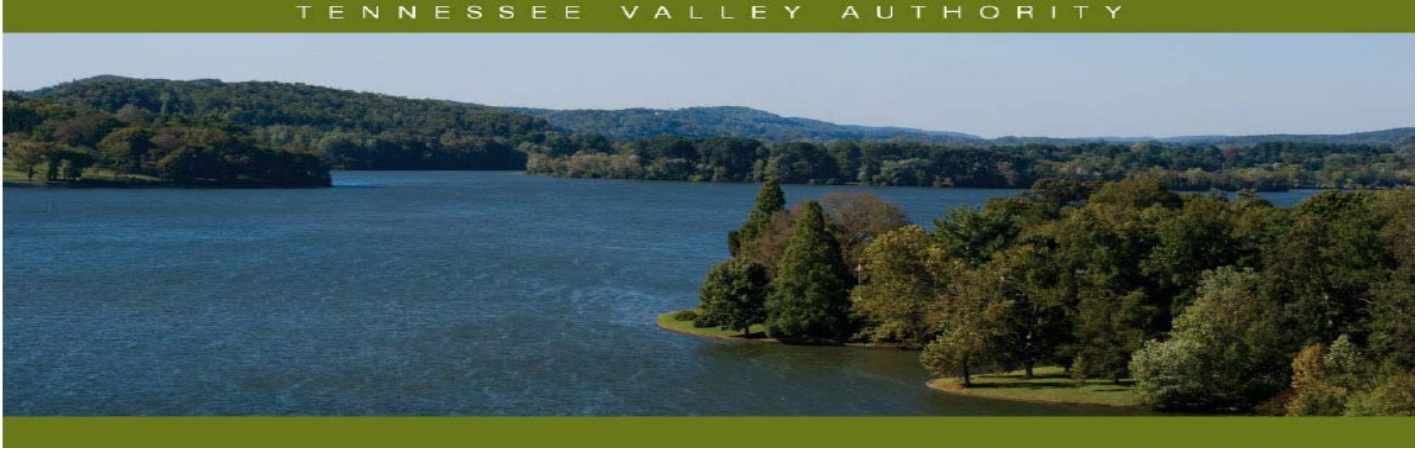

Reservoir Land Planning Errors

After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. Certain TVA reservoir land tracts have land management zone allocations based on the backlying land use. These zone allocations have the potential to conflict with access rights which qualify the adjacent property owners for consideration to receive a permit for a private dock or water use facility if the backlying land use were to change. The resolution of these potential conflicts has resulted in the reallocation of the TVA-managed land to align with the implied rights of egress and ingress of the adjacent property owners. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-310PT (XNR-310cPT) and is considered a supplement to the 2001 Norris RLMP. Norris Parcel 310 (XNR-310PT), Parcel 310c (XNR-310cPT)

XNR-310PT (24.15 acres) is located in Anderson County, Tennessee along the left bank at Clinch River mile 91.3. In the 2001 Norris RLMP, XNR-310PT is allocated for Zone 6 (Developed Recreation). However, a portion of XNR-310PT fronts a tract of former TVA land, XNR-604, which TVA sold subject to Section 31 of the TVA Act of 1933. In the deed, TVA granted the owners the right of ingress and egress to and from the waters of Norris Lake, these implied rights qualify the owners to be eligible for consideration to receive a permit for the purpose of constructing and maintaining water use facilities. A 1.03-acre portion of this land is not associated with a commercial recreation area and there are associated residential Section 26a applications. In order to resolve the potential conflicts from the 2001 RLMP allocations which do not allow for private water use facilities, a 1.03-acre portion of XNR-310PT was reallocated to "Residential Access" and designated as Parcel 310c (XNR-310cPT). XNR-310PT now consists of 23.12 acres and remains allocated as "Developed Recreation."

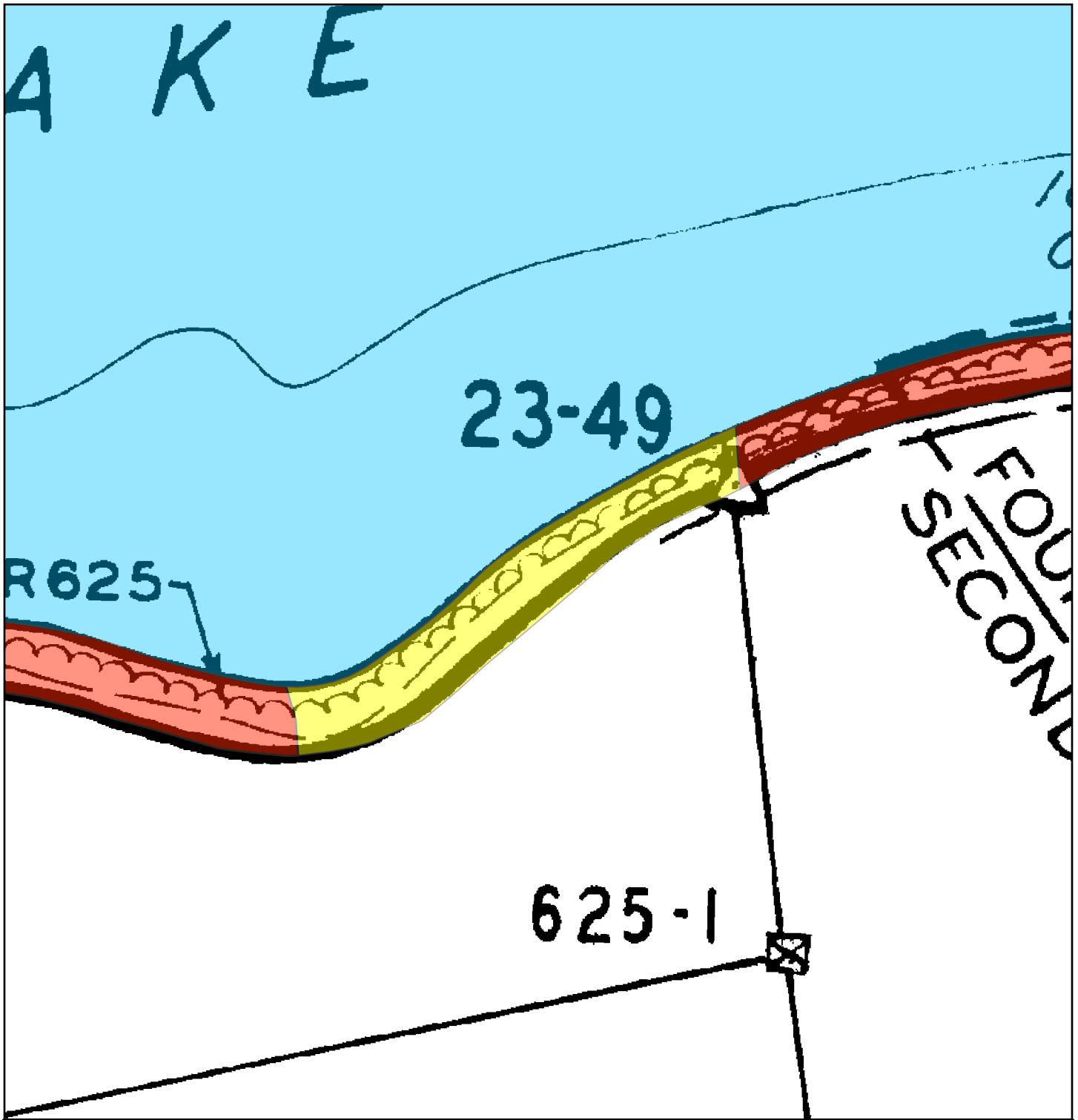






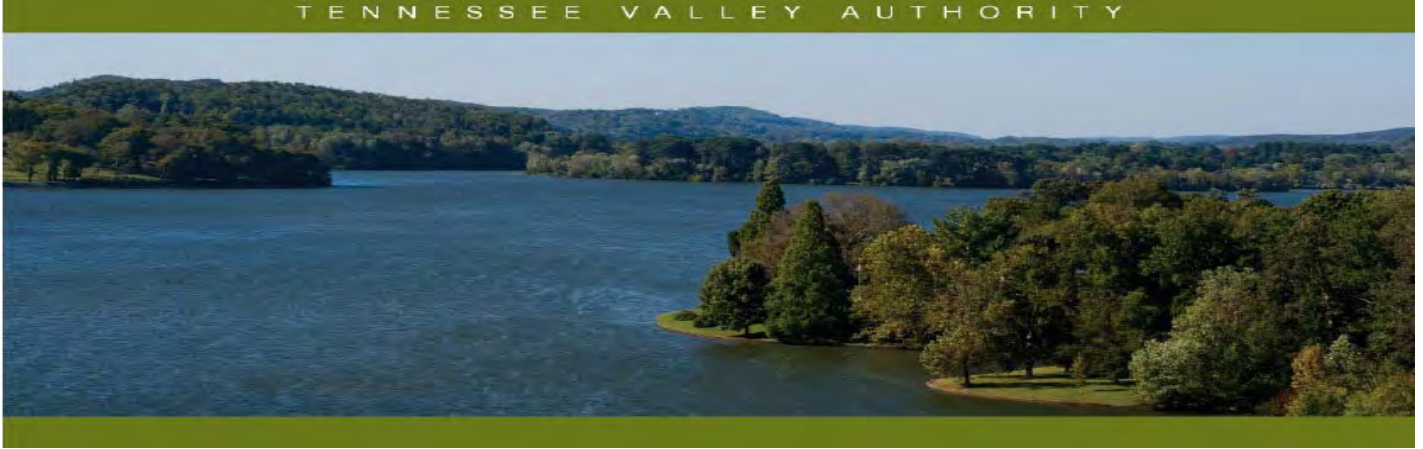

Reservoir Land Planning Allocation Changes

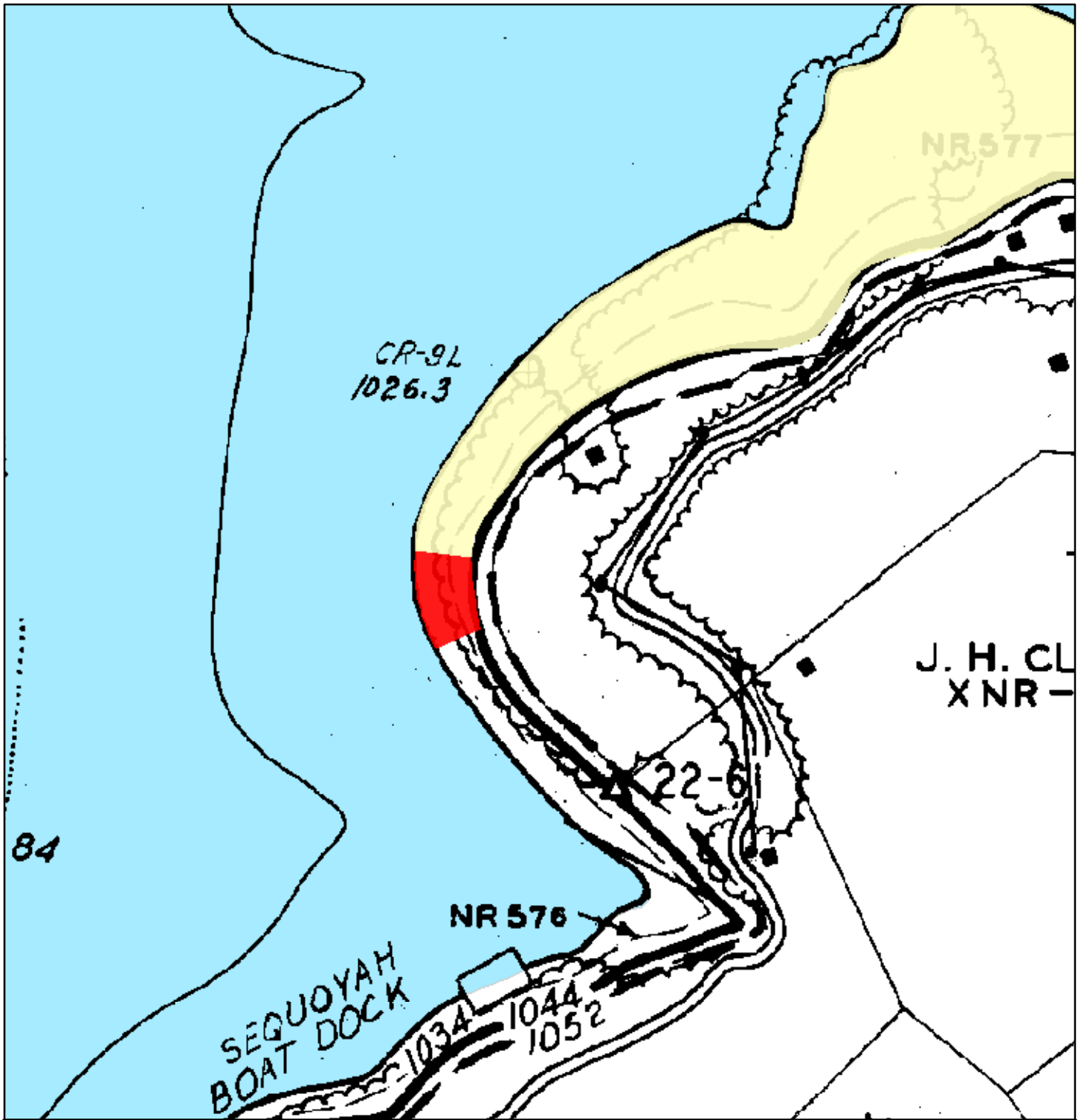
After approval of a reservoir land management plan (RLMP) by the Tennessee Valley Authority (TVA), future uses of TVA-managed lands on that reservoir must then be consistent with the land use allocations within that RLMP. Pursuant to TVA's Land Policy, TVA shall consider changing a land use designation outside of the normal planning process only for water access purposes for industrial or commercial recreation operations on privately owned backlying land. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-313PT (XNR-313aPT) and is considered a supplement to the 2001 Norris RLMP. Norris Parcel 313 (XNR-313PT) and Parcel 313a (XNR-313aPT)

XNR-313PT (68.01 acres) is located in Anderson County, Tennessee along the right bank at Clinch River mile 83.8L. In the 2001 Norris RLMP, XNR-313PT is allocated for Zone 7 (Residential Access). However, the private backlying property owner has requested Section 26a approval and an easement for a commercial recreation water-use facility on the TVA land fronting a portion of this property. The "Residential Access" land use allocation is considered incompatible with the request as proposed by the commercial operator. To allow consideration of the request and in accordance with the TVA Land Policy, TVA reallocated a 0.49-acre portion of the property, Tract No. XNR-313aPT, for "Developed Recreation." The remainder of XNR-313PT (67.52 acres) continues to be allocated as "Residential Access."

 XNR-313PT - Area to Remain Allocated as Zone 4 (Approx. 67.52 acres)

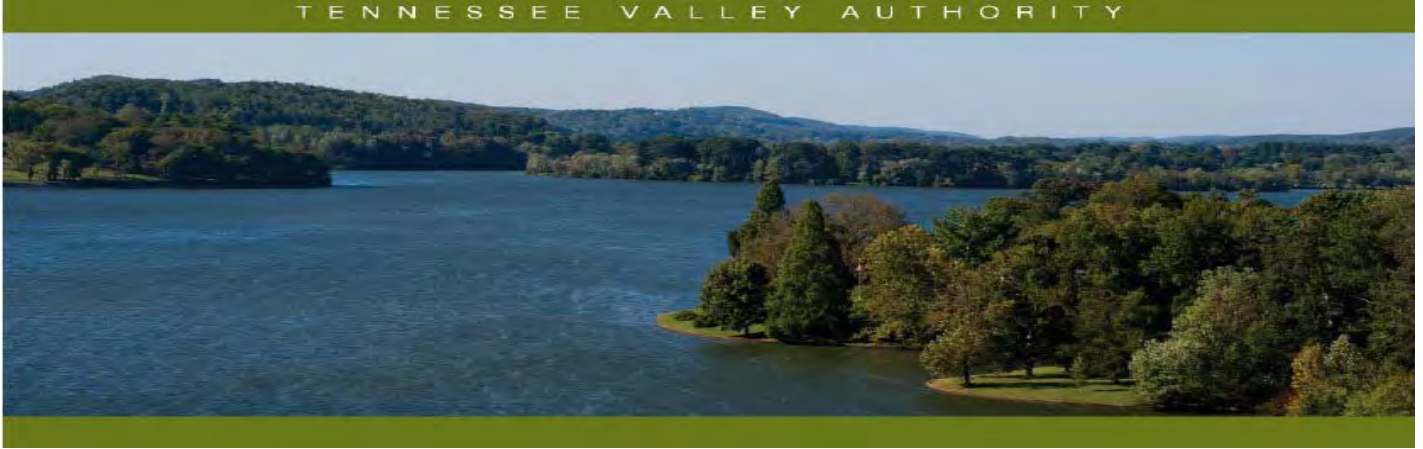

The resolution of these potential conflicts has resulted in the reallocation of the TVA-managed land to align with the ingress and egress rights of the adjacent property owners. This document addresses the reallocation of a portion of Norris Plan Tract No. XNR-315PT (new XNR-315aPT) and is considered a supplement to the 2001 Norris RLMP. Norris Parcel 315 (XNR-315PT) and Parcel 315a (XNR-315aPT)

XNR-315PT (5.3 acres) is located in Anderson County along the left descending bank of Clinch River mile 84.0 on Norris Reservoir. In the 2001 Norris RLMP, XNR-315PT was allocated as Zone 6 (Developed Recreation) for an existing commercial marina and resort. However, a portion of XNR-315PT fronts a tract of former TVA property, XNR-803, which TVA sold subject to Section 31 of the TVA Act. In the deed, TVA granted the owners the right of ingress and egress rights to and from the waters of Norris Lake over and upon the adjoining land lying between the 1044-foot contour elevation and the waters of the lake, and the deed does not contain any restrictions otherwise limiting those rights. In order to resolve the potential land use conflict with the allocation of "Developed Recreation", which does not allow for private water use facilities, a 0.5-acre portion of the 5.3-acre parcel will be modified as XNR-315aPT (see Exhibit Map) and the land use allocation changes from "Developed Recreation" to Zone 7 (Shoreline Access). The new 0.5-acre parcel (renamed XNR-315aPT) has approximately 186 linear feet of shoreline and the "Shoreline Access" allocation reflects the deeded access rights of ingress and egress across TVA shoreline property of the backlying property owners. Requests for private water use facilities would be considered on XNR-315aPT. The remainder of XNR-315PT remains allocated as "Developed Recreation."

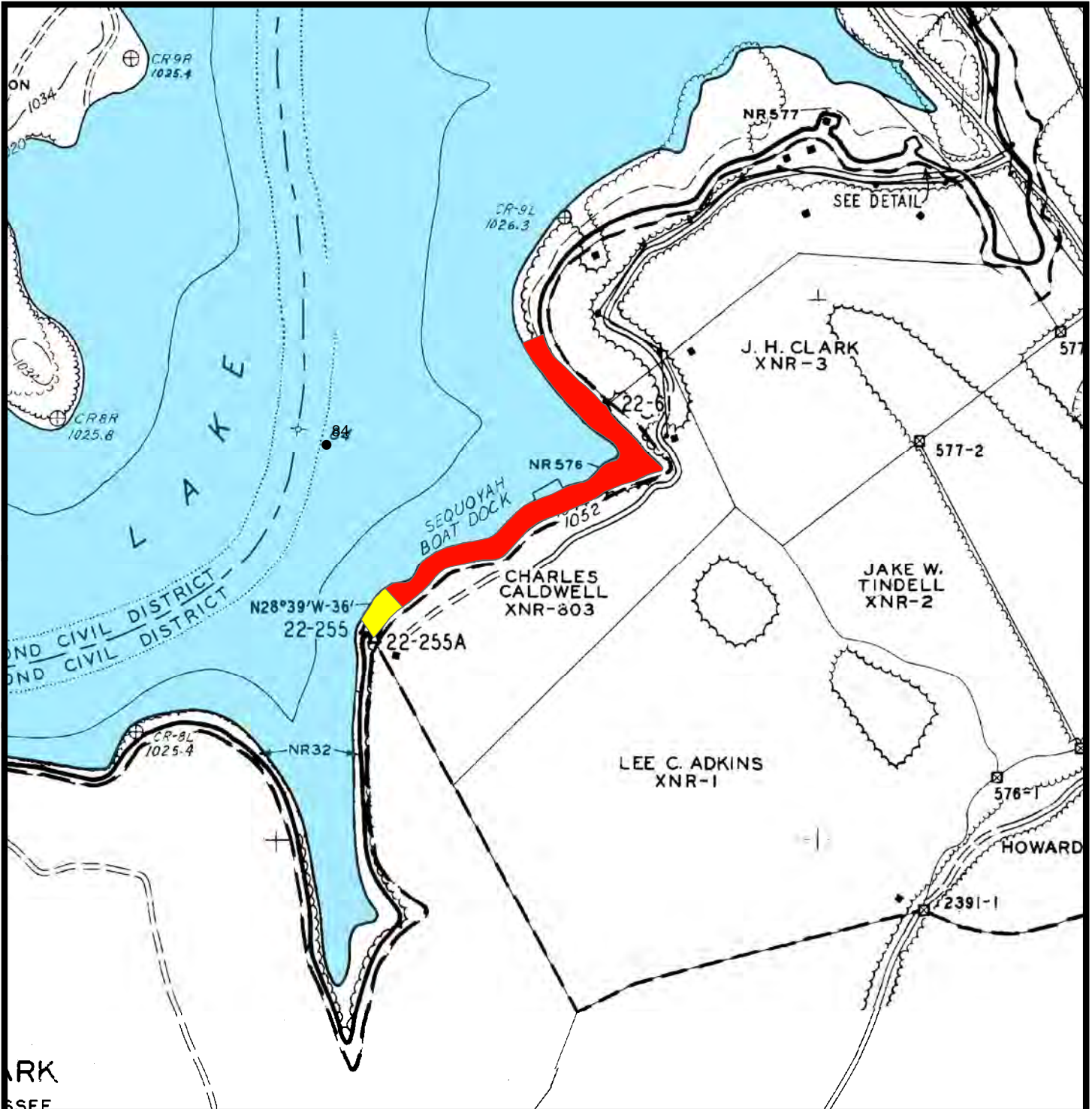

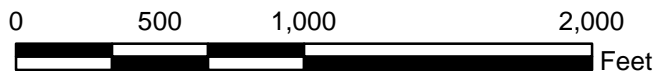
Land Use Allocation Change XNR-315PT and XNR-315aPT Anderson County, Tennessee Clinch River Mile 84.0L
